## 4. Working Budget

Luis provided an overview of the executive summary found on page 2 of the financial report.

- Enrollment is currently at 147 students
- Our Working budget is based on an enrollment of 145 students
- This working budget is an update of the original budget which was based on the enrollment of 243 students
- Luis will continue to focus on enrollment

## 5. Evaluation

- It was suggested items related to school finance and relationship to board governance be added
- Angie and Sam will meet with Luis regarding the continuation of this process

# 6. Updates

- Enrollment is at 147
- 12 incoming-kindergarteners are already enrolled for 2023-24
- Some concerns exist regarding heating within the building
- There are ongoing plumbing concerns regarding rust in the pipes
  - Luis received a quote for \$2,600 to fix the issue with the rust
- The final audit proposal has still not been received
- Luis has begun looking at staffing for next year
  - Hopeful all or most staff will return
  - There is a potential of losing 1-2 staff members
  - Right now EE will need to hire approximately 3 new teachers before next year
- EE will transition from BerganKDV for financial services at the end of this month
  - Luis is in contact with several vendors, however, the replacement has not been finalized
    - Luis says we will know more in the next 24-48 hours
  - Luis will work in the meantime to ensure a smooth transition. Luis will perhaps seek help in this.

The motion to pre-approve Luis to go into an agreement with a replacement financial services provider, provided it fits within EE's current budget of \$4,275/month, was moved by Andrea and seconded by Ingris. The motion carries.
